

**BINGO SHOWDOWN'S BINGO CRUISE RAFFLE**  
**OFFICIAL RULES ("Official Rules")**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND DC, 21 YEARS OF AGE AND OLDER WHO ENTER FROM WITHIN THE 50 UNITED STATES OR THE DISTRICT OF COLUMBIA. THIS PROMOTION IS INTENDED FOR ENTRY IN THE UNITED STATES ONLY AND WILL BE CONSTRUED AND INTERPRETED UNDER THE LAWS OF THE UNITED STATES. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED IN THE UNITED STATES AT THE TIME OF ENTRY. VOID WHERE RESTRICTED OR PROHIBITED BY LAW.**

1. **ELIGIBILITY:** The Bingo Showdown's Bingo Cruise Raffle ("**Promotion**") is open to legal residents of the 50 United States and the District of Columbia, 21 years of age or older, who are located in the United States or the District of Columbia at the time of entry. Employees, contractors, directors and officers of SciPlay Games, LLC ("**Sponsor**") and each of their parent, affiliates and subsidiaries, and members of the immediate family (spouse, parent, child, sibling and their respective spouse) and household of each such employee are not eligible to participate.
2. **DESCRIPTION/ENTRY PERIOD:** This Promotion begins at 10:00AM CST on January 27, 2022 and ends at 10:00 AM CST on June 30, 2022 ("**Giveaway Entry Period**").
3. **HOW TO ENTER:** No purchase necessary. During the Giveaway Entry Period, eligible entrants may receive entries in the Promotion through regular gameplay of Sponsor's Bingo Showdown video game ("**the Game**"). Play does not require purchase and can be made utilizing free currency. Each bingo a player makes in the Game will provide one entry to the Promotion.

Players may not enter multiple times with multiple accounts. Multiple entries may result in disqualification.

Email Entry: Players may also enter the sweepstakes via email. Send an email to [promotiongiveaway@BingoShowdown.zendesk.com](mailto:promotiongiveaway@BingoShowdown.zendesk.com) with the subject line "Bingo Showdown Bingo Cruise Raffle Email Entry." In the body of the email you must include your valid player id from the Game (located in the settings menu of the Game), name, address, city, state, ZIP code and date of birth. To be eligible for the sweepstakes drawing, no automation may be used and email entries must be received by 10 AM CST on June 30, 2022. Each player may submit one free request once per day and Sponsor will provide 9 entries to the Promotion per request.

4. **DRAWINGS/ODDS:** The odds of winning will depend on the number of entries received. On or around **June 27, 2022**, a random drawing will take place to select 1 grand prize winner, 1 first prize winner, 1 second prize winner and 1 third prize winner from among all eligible entries received. Winners will be notified **on July 1, 2022** through an in-game pop-up message in the Game. The grand prize winner will also receive notification by email if SciPlay has the email address. Odds of winning depend upon the number of eligible entries received during the Giveaway Entry Period. Sponsor's decisions regarding winners are final.
5. **CONDITIONS OF ENTRY:** By entering, entrants acknowledge compliance with these Official Rules, including all eligibility requirements. To be valid, each entry must follow the directions noted above in section 3. The Sponsor is not responsible for lost, late, incomplete, invalid entries, computer error or malfunctions. The Sponsor is not responsible for incorrect or inaccurate transcription of entry information, human, printing or other errors, technical malfunctions, or any other error or malfunction. Automated entries are prohibited, and any use of automated devices will cause disqualification. Entrants may not enter with multiple e-mail addresses nor may entrants use any other device or artifice to enter multiple times or as multiple entrants. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, accounts, identities, registrations, logins, or any other methods may void that entrant's entries and that entrant may be disqualified (and forfeits all prizes won), in Sponsor's discretion. In the event of a dispute as to any entry, the "authorized account holder" will be deemed to be the entrant and he/she must comply with these Official Rules. "Authorized account holder" is defined as the natural person who is assigned an email address by organization that is responsible for assigning email addresses or the domain associated with the submitted entry. A potential winner may be required to show proof of being the authorized account holder associated with the entry.
6. **Modifications and Cancellations:** Sponsor reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, if any fraud, bugs, virus, technical failures, or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Promotion, as determined by Sponsor in its sole discretion. In the event of cancellation, Sponsor will randomly award the prizes from among eligible, non-suspect entries received prior to cancellation. Sponsor is not responsible for computer system, phone line, hardware, software or program malfunctions, or other errors, failures or delays in computer transmissions, the website, or network connections that are human or technical in nature. Sponsor reserves the right, in its sole discretion, to disqualify any

individual it finds to be tampering with the entry process, the website, or the operation of the Promotion or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

and submission of shipping address. If Sponsor is in possession of the grand prize winner's email address, the winner will also receive notification by email. Sponsor is not responsible for any change of email address, mailing address, and/or telephone number of entrants.

9. **BINDING ARBITRATION:** Any controversy or claim arising out of or relating to this Game shall be settled by binding arbitration in a location determined by the arbitrator as set forth herein (provided that such location is reasonably convenient for claimant), or at such other location as may be mutually agreed upon by the parties, in accordance with the procedural rules for commercial disputes set forth in the Comprehensive Arbitration Rules and Procedures of JAMS ("JAMS Rules and Procedures") then prevailing, and judgment upon the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof. The arbitrator shall be selected pursuant to the JAMS Rules and Procedures. The arbitrator shall apply Nevada law consistent with the Federal Arbitration Act and applicable statutes of limitations, and shall honor claims of privilege recognized at law. In the event that the claimant is able to demonstrate that the costs of arbitration will be prohibitive as compared to the costs of litigation, Sponsor will pay as much of the claimant's filing and hearing fees in connection with the arbitration as the arbitrator deems necessary to prevent the arbitration from being cost-prohibitive. If any part of this arbitration provision is deemed to be invalid, unenforceable or illegal (other than that claims will not be arbitrated on a class or representative basis), or otherwise conflicts with the rules and procedures established by JAMS, then the balance of this arbitration provision shall remain in effect and shall be construed in accordance with its terms as if the invalid, unenforceable, illegal or conflicting provision were not contained herein. If, however, the portion that is deemed invalid, unenforceable or illegal is that claims will not be arbitrated on a class or representative basis, then the entirety of this arbitration provision shall be null and void, and neither claimant nor Sponsor shall be entitled to arbitrate their dispute. Upon filing a demand for arbitration, all parties to such arbitration shall have the right of discovery, which discovery shall be completed within sixty days after the demand for arbitration is made, unless further extended by mutual agreement of the parties. THE ARBITRATION OF DISPUTES PURSUANT TO THIS PARAGRAPH SHALL BE IN THE ENTRANT'S INDIVIDUAL CAPACITY AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING. THE ARBITRATOR MAY NOT CONSOLIDATE OR JOIN THE CLAIMS OF OTHER PERSONS OR PARTIES WHO MAY BE SIMILARLY SITUATED. DO NOT ENTER THIS GAME IF YOU DO NOT AGREE TO HAVE ANY CLAIM OR CONTROVERSY ARBITRATED IN ACCORDANCE WITH THESE OFFICIAL RULES.

SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY SET FORTH ABOVE AND IN SECTION 9, SO SUCH LANGUAGE MAY NOT APPLY TO EVERY ENTRANT.
